

### Owner Liability Waiver and Health Certification

I, \_\_\_\_\_, hereby certify that my dog, \_\_\_\_\_ is in good health and has not been ill with any communicable illnesses or conditions in the last 15 days. I further certify that my dog has not harmed or shown aggressive or threatening behavior toward any other dog or person. I have read and understand the following:

1. I understand that I am solely responsible for any harm caused by my dog while my dog is at Praiseworthy Pups Training and Daycare.
2. I further understand and agree that in bringing my dog to Praiseworthy Pups, the staff has relied on my representation that my dog is in good health and has not harmed or shown aggressive or threatening behavior towards any person or other dog. The Praiseworthy Pups staff may, at any time, immediately remove a dog from training, daycare, or any other activity if he/she exhibits behavior that could be harmful to other dogs or staff.
3. I further understand and agree that Praiseworthy Pups and its staff will exercise due diligence and reasonable care while caring for my pet, and will not be liable for any problems that may arise. I hereby release Praiseworthy Pups of any liability of any kind whatsoever arising from my dog's attendance and participation.
4. I further understand that my dog will be training and/or playing in open areas with other dogs and accept that minor cuts and scratches may occur. If I am not present and my dog becomes injured or ill and is in need of immediate care, Praiseworthy Pups staff will, at their sole discretion, treat my dog as deemed necessary and will attempt to call me at the contact phone numbers I have listed on my application.
5. If illness or injury is serious and immediate action is deemed necessary by Praiseworthy Pups staff, the dog will be transported to a veterinary clinic or hospital. I understand that an attempt will be made to reach me while the animal is in transit. If I or my emergency contact is unreachable, Praiseworthy Pups staff has my permission to authorize the veterinarian to proceed with any treatments deemed necessary. I will assume all financial responsibility for veterinary treatment.
6. **If enrolling my dog in training or daycare**, I certify that I have read and understand the policies of Praiseworthy Pups as set forth on the [www.praiseworthy pups.com](http://www.praiseworthy pups.com) Website and that I have read and understand the conditions and statements in this agreement.
